Course Overview:

This course examines the range of common psychological disorders (with a focus on adults), their characteristic symptoms, and possible causes. We will also discuss treatments for these mental health issues, but this will not be the primary focus of the class. The course will include information related to basic conceptualizations of "abnormal behavior," historical perspectives

on psychopathology, research methods and assessment, and emerging issues in the mental health field. We will use readings, class discussions, film clips and activities to further your understanding of common psychological disorders.

Course Requirements and Grading Information:

Readings: You should complete required readings prior to the class module. This will help you to engage with the course materials.

Attendance: We will not take attendance in this class and I will not monitor your viewing of course materials or attendance for the live sessions. However, it is to your benefit to review all course materials, including readings and videos, as well as the live sessions. Class lectures will include additional information that is not covered in your book and although basic lecture slides will be made available, these will be simplified and will not include the full information/notes reviewed in the videos. Quizzes will cover lecture material that is not available in the book or the PowerPoint slides that may be reviewed via the video lectures and module materials.

Module Assignments: Each week, there will be brief assignments available for you to complete on D2L to engage you in learning the materials. Each week, these will count for 5 points. You'll have a week from Monday each week to complete these assignments. Across the 16 weeks, you will be able to accumulate up to 80 points from these assignments. There will not be opportunities to make up these assignments and any missed assignments will be recorded as a 0.

Quizzes: There will be quizzes every other week, covering the content over the 2 week period. You may use your notes and your book on these quizzes, but you should not work with others on the assignments. Each quiz will count for 50 points and there will be 8 quizzes for a total of 400 points. Most of your grade in the course will come from these quizzes. The quizzes will cover information from the book, lecture slides and videos, and any module materials posted to D2L. There will not be any opportunities to make up these quizzes and a missed assignment will automatically be recorded as a 0. They will be available for a 24 hour period and will be released at 9:00 AM the Fridays they are released on.

Paper: Students will need to complete one paper in this course worth 100 points. For this paper, you will need to choose a blog to read/follow from a person living with a mental illness. The paper provides you with an additional opportunity to learn about someone's personal experience. This paper will be due by October 23rd at 5:00 PM. You can turn in the paper ahead of time, but it will not be graded until after the due date. Papers will be submitted to screen for plagiarism. Any copied papers will receive a 0 and you will be unable to redo the assignment. **The paper should be 3 pages long, double spaced, 12 point times new roman font, and include the following:**

- A description of the person, their blog, and the disorder they are speaking about
- Analyze how their description of their experiences align to the course material
- Discuss how this disorder has impacted their lives
- Has this person been stigmatized because of having a mental illness? If they discuss this in the blog, how has this influenced their experiences or how others have treated them? If they do not directly discuss this, then describe how you think they might experience stigma.

Honors Option: If you are an honors student and interested in this option for the class, you will write a more extended version of the class paper (4 pages instead of 3 pages). The details about this assignment will be made available on D2L.

CLASS POLICIES

There are a lot of policies below and I think these are important to read through for transparency and to help you be on the same page as myself/university requirements. Please read them and reach out if you have questions about any of them. Before you do though, I do want to mention that we are likely in for a challenging semester with COVID-19. Please know that your well-being is important to me. If you are struggling in the class, please seek me out sooner rather than later. The earlier we address what is going on, the more likely it is that you can recover and get back on track. My goal is to make it possible for all students to have a successful educational experience in this class.

5. Attendance and Missed Exams:

Students whose names do not appear on the official class list for this course may not attend this class. If you miss a class, it is your responsibility to get notes from another student.

In the event that you miss assignments or quizzes, you will receive a 0. If you are experiencing a medical emergency that results in your missing the assignment, you should contact the instructor before the exam (or as soon as reasonably possible) to arrange for a makeup. If this occurs, you must provide written documentation from a doctor's office verifying your report. Failing to do so may result in your being unable to take the exam.

9. Turnitin:

The tool compares each student's work with an extensive database of prior publications and papers, providing links to possible matches and a "similarity score." The tool does not determine whether plagiarism has occurred or not. Instead, the instructor must make a complete assessment and judge the originality of the student's work. All submissions to this course may be checked using this tool.

Students should submit papers to Turnitin Dropboxes without identifying information included in the paper (e.g., name or student number), the system will automatically show this information to faculty in your course when viewing the submission, but the information will not be retained by Turnitin.

Student submissions will be retained in the Turnitin repository for comparison with other student papers in this class and in future classes.

10. Recordings of Course:

Meetings of this course may be recorded. The recordings may be available to students registered for this class. This is intended to supplement the classroom experience. Students are expected to follow appropriate University policies and maintain the security of passwords used to access recorded lectures. Recordings may not be reproduced, shared with those not in the class, or uploaded to other online environments. Doing so may result in disciplinary action. If the instructor or another University office plan other uses for the recordings beyond this class, students identifiable in the recordings will be notified to request consent prior to such use.
