## **General Information:**

This course will be using Desire 2 Learn for on-line course management and communication. You can access D2L by going to <a href="https://d2l.msu.edu">https://d2l.msu.edu</a>. #### **Required Materials for this Semester:**

There are no required books or materials to purchase; all required materials/articles will be provided in D2L.

#### **Course Purpose:**

The purpose of this course is to provide you with an opportunity to try out a field of interest while taking time to increase your job network, learn transferable skills, and reflect on your career readiness plan. During this semester you will be spending most of your time as an intern at a designated placement site that you have found related to your career goals.

#### **Course Format:**

This online course provides you with the opportunity to receive structured supervision of your internship experience no matter where your work occurs. You may sign up for a minimum of 3 to a maximum of 12 credits this semester and must work 3 hours per week at your organization per credit hour (from 9 to 36 hours per week). In addition to the time spent working in your placement, you are expected to complete the following activities through the D2L website set up for this course.

## **Course Assignments**

## **Unit Discussion Boards:**

• Each student is expected to participate in the discussion boards throughout the semester. These allow you to discuss your internship with other students from the course. The first 3 units will each have a discussion board topic based on the unit readings. In addition to posting a thread to the discussion, it is expected that you will respond to at least 1 other classmate's post. Reflecting on your experience and learning from your peers is a crucial component to this course. There will be 3 graded discussion boards each worth 25 points for a total of 75 points. Grades will be assigned based on the thoughtfulness and details of your post as well as your engaging responses to other classmates. While the discussions will not be graded until the end of each unit, you should post to the discussion within the first week of the unit beginning to allow time for responses from classmates.

## **<u>Unit Hour Log:</u>** Due Monthly, see chart

- In the D2L site, there is an Excel hour log document that you will need to download and save to track your internship hours and to complete the unit hour check in. Hour logs will be evaluated on their completeness and thoughtfulness. The document should be saved and used as a running log throughout the semester. As a first step, fill out the first tab of the log, including your semester, name, internship site and # of credits enrolled!
- Your hour log will track your total hours completed during the internship as well as ask you to list the skills you have learned, challenges you faced, a proud moment, and areas you hope to improve at the end of each unit.
- Your hour log will be used as one way of determining your grade for this course. You need to electronically submit your hour log to D2L by 11:59 PM (EDT) on the unit deadlines listed below. Hour logs submitted late will be marked down 5 points for each day late.
  - Please note the units end on the last day of the month so may vary on the day of the week they are due. Unit 4 is shorter based on the course final exam week.

- Each of the first three logs is worth 25 points. Each section is worth 5 points (Sections include (1) hours for the month; (2) skills learned; (3) challenges; (4) proud moment; (5) areas to improve). The instructor will base grades on the completeness and thoughtfulness of information provided in your hour log, discussions with the student, and/or direct information received from the internship agency supervisor. NOTE: Log Four does not have a numerical grade, but must be turned in to confirm hours completed! You cannot pass without the final hour verification.
- Please follow the instructions on D2L for accurately completing and submitting your unit hour log. <u>The instructor may leave feedback on your hour log submissions</u>, so please read the comments.

**Goal Setting:** Due Saturday, May 31st 11:59 PM

• After reviewing the Unit 1 readings on SMART Goal setting, use a word document and provide 2 short term SMART goals and 2 long term SMART goals you have yourself. Apply the format detailed in the articles with "Goal Setting" on D2L. These could be related to your internship this semester or to your future career/graduate school interest areas. Goals should be detailed to show thoughtful reflection. Submit the assignment to the Dropbox in unit 1 within D2L. Also, add your goals to the hour log Internship Goals section. (50 points)

## Am I Career Ready?: Due Monday, June 30th 11:59 PM

- Focus 2 is an online, self-guided, interactive program designed to help you explore majors and careers. Assessments are available to help you examine your **personality**, **skills**, **interests**, **work values**, **preferences and competencies**.
- For this assignment you will complete the "Am I Career Ready" self-assessment at: https://www.focus2career.com/Portal/Login.cfm?SID=1870.
  - Create an account click the link above and then click the 'create an account' button. Complete the onscreen information to create your account (Access Code: spartan).
  - Log In once logged in, find the "Am I Career Ready?" assessment and click on the icon. Next, review the eight career competencies and then scroll down and click on 'Begin Module.'
     Complete the questions until you reach the Assessment Results chart.
  - O Assessment Results click on the ( ) icon to download your results chart as a jpeg, png, jfif please rename this file as [LastName.AmICareerReady]. You are encouraged to read the text of your results as well. Further exploration in this module is optional but strongly encouraged.
  - Assignment in a Microsoft Word document, address the following questions. Format = double space, size 12 font. Responses to the questions should be detailed to show thoughtful reflection.
    - Do you feel the assessment accurately represents your skills at this point? Why or why not? Provide examples.
    - Choose three of your <u>least</u> developed career competencies list each one, with its NACE (National Association of Colleges and Employers) definition (<u>located here</u> - <a href="https://www.naceweb.org/career-readiness/competencies/career-readiness-defined">https://www.naceweb.org/career-readiness/competencies/career-readiness-defined</a>).
    - Can you use your internship to work on building these skills? If so, how? If not, why not?
    - Identify two strategies, activities, etc., you might use to develop each competency outside of your internship.
- Upload <u>both</u> the downloaded JPEG report and your typed responses in the D2L Dropbox in Unit 2. (50 points)

### **Interview Prep:** Due Thursday, July 31st 11:59 PM

- Interview Prep is an online resource designed to help students prepare for virtual interviews. Students can practice virtual interviewing, review common interview questions and practice answers, and get feedback. This is valuable as some companies shift to pre-recorded or AI interviews.
- For this assignment you will complete a practice interview at: <a href="https://msu.interviewprep.app/">https://msu.interviewprep.app/</a>.
  - Register click the link above and then click the 'Register' link. Complete the onscreen information to create your account/register.
  - Log In once logged in, click on the "Prepare" tile to find resources to prep for your virtual interview. Then, click on the "Conduct" tile. Click on "Practice Interviews," scroll over the 'Common Questions' tile, and click on 'view questions' if you'd like to do more prep, or 'start interview' when you're ready to begin. Back on the home page, click on the 'Conduct' tile and follow the onscreen directions for the interview.

- Assessment Results click on the "Review" tile to watch pieces of your interview, sorted by question. At the bottom of the screen, complete the self-assessment; once completed, click on "Download Assessment" please rename this file as [LastName.InterviewPrepAssessment].
   NOTE: your interview video/audio will only be accessible to you. Your grade for this assignment is NOT based on your ability to interview.
- Assignment in a Microsoft Word document, address the following questions. Format = double space, size 12 font. Responses to the questions should be detailed to show thoughtful reflection.
  - Name three areas where you feel proficient in interviewing. Name three areas where you feel you can grow in interviewing.
  - Can you use your internship to work on building up your areas of growth? If so, how? If not, why not?
  - Identify two strategies, activities, etc., you might use to develop your growth areas outside of your internship.
- Upload <u>both</u> the downloaded self-assessment and your typed responses in the D2L Dropbox in Unit 3. (50 points)

## Evaluation Forms: Due Thursday, July 31st 11:59PM

- Student Evaluation of Internship Organization (Student self-reflection)
  - We would like to know your impressions of your internship site. Would you recommend it to others? What was positive? What needs to be improved? A "Student Evaluation of Organization Site" form can be found on the D2L course page under Unit 3. Please complete the evaluation by the end of unit 3 and submit it to the "Student Evaluation: Dropbox in D2L. This evaluation will be viewed only by the instructors of the course and not shared with supervisors. (25 possible points)
- Organization Evaluation of Student (To be completed by supervisor and reviewed together)
  - You are also responsible for asking your internship supervisor to complete an evaluation of your work. An "Organization Evaluation of Student Intern" form can be found on D2L under Unit 3. Please provide your supervisor with a printed copy of the evaluation form to complete. Once completed you both should schedule a meeting to review and discuss your performance and accomplishments this semester. After discussing the evaluation together, both student and supervisor should physically sign the document. Blank or electronic signatures will not be accepted. The completed, signed document, should then be uploaded to the "Supervisor Evaluation" D2L Dropbox.

Points are not assigned to this evaluation; However, you cannot pass this course without this evaluation form completed by your supervisor, so please do not wait until the last minute; this is extremely important.

• Unit 4 will open an Internship Spotlight Reflection form. The form will have questions related to your overall experience at the internship. For each question it is expected that you will **provide thorough** responses to show critical thinking reflection of your experiences. The form will also ask if we have permission to feature you for a future internship spotlight utilizing your responses to the questions provided. Opting out of being featured will not impact your grade. Once you complete the form you will automatically receive a copy of your submitted responses to your MSU Email account. From your MSU email inbox, open the email and then select save as adobe PDF. Save file as LastName\_InternshipSpotlight and upload the document to the appropriate dropbox in D2L. (50 possible points)

## Resume Update: Due Friday, August 15th 11:59PM (Extra Credit)

- For this assignment, you will simply need to add your internship experience to your current resume. It is good practice to make sure you are updating your resume after/during your experiences rather than waiting until you need your resume for a job/volunteer application. This allows you to always have your resume ready to go when an opportunity arises. Your hour log that will be used during this course is designed to have you record skills and proud moments that will allow you to have a place to return to when updating your resume to make sure you are not leaving out key skills you have gained. (15 points)
- Not required but encouraged, once you have your resume updated, submit it for a review by the College of Social Science career advisors/peer. You can submit your resume for an electronic review by emailing sscareer@msu.edu.

## **Late Assignments**:

• Late assignment submissions will be allowed up to 3 days after the assignment deadline. For each day late 5 points will automatically be deducted from the total possible points. If past the 3-day mark, please contact the instructor regarding making up past due work.

In addition to this point system, there is potential for immediate termination (with a grade of 0.0/NP) due to illegal, unethical or improper behavior, which includes not following project guidelines and philosophies when conducting your internship. You also **MUST** ensure that your supervisor's evaluation of your performance is submitted to the instructor by the due date for your grade to be released.

## Number of Hours You Need to Complete

Your total number of hours expected will be based on 13 weeks to allow for holiday and sick time. A student taking 3 credits needs to complete 117 hours (3 credits x 3 hrs per credit per week x 13 weeks). You are expected to be interning the duration of the full semester unless prior arrangements have been made with the instructor. One point of this internship is for you to spend an extended period with an organization. *This means that even if you have completed all your required total hours prior to the end of the course, you CANNOT end your internship early*.

## **D2L Tracking:**

Please be aware that D2L tracks <u>all</u> student login information. For example, it tracks when you have logged into D2L and when you have logged out. It also tracks when you submit assignments. This is helpful for the instructor because it allows me to resolve issues if there is a problem with the D2L system in terms of logging

on and/or gaining access to the various sections of the site. Tracking can also help me resolve disputes about assignments. D2L tracking also can reveal academic misconduct.

## **Submitting Assignments:**

- 1. Save file as: Lastname Firstname AssignmentName
  - a. Example: Murray\_Andrew\_HourLog (please use the underscore, do not just use a space)
- 2. Save as a .doc or .xlsx—NOT .notes or .heic or similar)
- 3. Attach the document in D2L
  - a. Do not copy and paste your assignment into the D2L comment box
- 4. After you submit your assignment, go back, and check to make sure the document was successfully attached (you will see the attached document's file name if it was attached correctly)
  - a. If you have issues with uploading your assignments, email the instructors before the deadline.
  - b. Your assignments will be considered late and points will be deducted accordingly if the document is not attached AND you do not email it to the instructor to inform them of issues.
